# Why do you need to attend the HSA Community Meeting on the Budget?

- The City is currently projecting a \$125 million General Fund shortfall in FY08-09 and a \$250 million General Fund shortfall in FY09-10. The Mayor's Office will propose a significant reduction in the Department's General Fund budget.
- The meeting will provide community members and non-profit organizations with an update on the City's funding projections and an opportunity to weigh-in on strategies to reduce Department costs.
- This meeting will provide an opportunity for individual discussions on Family & Childrens Services, Economic Support & Self Sufficiency, Child Care, and Housing & Homelessness programs.

## What topics are going to be covered?

- FY2008-09 mid year reductions, Mayor's Office budget directives, economic forecasts, and spending plans.
- Potential service changes and program restructuring in divisions throughout the Department.
